On Monday, July 25, 2022, at 5:30pm, the Township Board will convene to hear information relative to the status of the Town & County Motel property and Motel's license, #CHML22-06.

Enclosed in the Board packet, please find the NOTICE OF REVOCATION HEARING ("NOTICE") issued to the Motel Licensee, Ms. Shuang Fan. Also enclosed in the packet is information received from Ms. Fan subsequent to the Township's issuance of the NOTICE letter to Ms. Fan.

The Township, by way of Ordinance No. 2017-03-1, adopted the 2015 International Property Maintenance Code ("IPMC"), and by way of Ordinance Nos. 2017-09-02, § 2, 10-9-2017, 2017-03-1, the Township adopted the 2015 International Fire Code ("IFC").

The Township's NOTICE to Ms. Fan alleges numerous Township Ordinance violations and IPMC and IFC violations. The alleged violations impact the operation of the Motel and pose risk to persons on and near the property. As such, Township officials recommend that the Motel license be suspended or revoked until such time the Motel passes applicable inspections.

This matter will be represented before the Board by Township Attorney David Revore, and may include several witnesses: Allan L. Hoard Jr., DeWitt Charter Township Building Official, Cory Donnell, DeWitt Charter Township Official; Mark Nicholson, DeWitt Charter Township Official. The evidence will also include photographs of the Motel.

The Licensee is entitled to legal counsel of her choice. She will have the opportunity to cross-exam the Township's witnesses and evidence. The Licensee may also present her witnesses and evidence.

After the evidence is presented and legal counsel has finished closing remarks, the Board may deliberate in open session to consider whether to take action to suspend or revoke the license or provide the Licensee more time to complete Motel repairs and pass applicable inspections.
