Webb Road Pathway Project – Resolution R2023-01-02, Agreement for Adjustment

The 2023 Adopted Budget included a \$250,000 allocation towards the Webb Road Pathway Project based on estimates at that time. The revised Township share estimate provided by the Clinton County Road Commission is \$362,900.

Improvements, Budget Fedewa moved, Smith seconded, the following actions:

- 1. Approve Resolution 2023-01-02 to authorize the Clinton County Road Commission to act as the Act 51 agency on their behalf and commit to owning, operating and funding/implementing a maintenance plan/program over the design life of the proposed improvements and reimbursing the costs for engineering and possible construction match.
- 2. Authorize the Supervisor, Clerk, and Treasurer to execute an agreement with the Clinton County Road Commission for the Webb Road Pathway project at an estimated Township cost of \$362,900 (cost includes \$40,000 project contingency).
- 3. Approve the following budget adjustments to the 2023 Budget:

EXTENDED PUBLIC, Robert Mack, 11849 Schavey Rd., inquired about the timing of fiber optic cable installation on Howe Road. Manager Dymczyk offered to follow up with timing.

> Fire Chief Dave DeKorte informed the Board that the Fire Department has recently been busy assisting neighboring communities with structure fires.

> Police Chief Matt Merony reported a recent surge in stolen vehicles, and the number of responses requiring psychiatric intervention is increasing. Lastly, he informed the Board that he had spoken with the owner of Rotunda Trailer Park and that the cleanup is beginning.

Manager Dymczyk offered updates on the following:

The new part-time Administrative Assistant has begun working, and it is necessary for the Board to waive Section 7 of the Personnel Manual, should they desire to do so, as the new hire has a relative working elsewhere in the Township.

Galardi moved, Cramton seconded, to waive the requirement of the DeWitt Township Personnel Manual, Section 7: Employment of Relatives, as it applies to the hiring of part-time Treasurer's Office Administrative Assistant, Sue Spagnuolo, as allowed by the above stated section, and record of waiver to be retained in Ms. Spagnuolo's personnel file.

Treasurer Stump thanked the Board for their consideration in voting to waive the Employment of Relatives section of the Personnel Manual. Her office is now fully staffed.

Clerk Cramton offered that, thanks to the waiver, the Township can be confident that we have hired the best candidate. The Clerk's Office will be undergoing an election audit for precinct five records and process on February 7th. There is a special meeting of the Board scheduled at 6:00 PM on Monday, January 30th, for a public hearing for the consideration of license revocation for Westview Motel. Clerk Cramton will post the agenda and circulate packets after a meeting with legal on January 26th.
